SECTION 4: First aid measures

4.1. Description of first aid measures

Inhalation

Move affected person to fresh air at once. Get medical attention if any discomfort continues.

Ingestion

Rinse mouth thoroughly with water. Give plenty of water to drink. Get medical attention immediately.

Skin contact

Appropriate engineering controls
